Your Covid-19 vaccination status

Depending on your age and vaccination status, you may not be required to self-isolate or take a Day 8 test upon your arrival in the UK from an amber country as long as you:

- have been fully vaccinated under the UK vaccination programme, at least 14 whole days before the date you arrive **or**
- have been fully vaccinated under a vaccination programme approved by the UK at least 14 whole days before the date you arrive **or**
- are a participant in a formally approved COVID-19 vaccine clinical trial in the UK (or one approved by the UK) **or**
- ordinarily resident in the UK and under the age of 18 at the time you arrive **or**
- ordinarily resident in a country with a vaccination programme approved by the UK and under the age of 18 at the time you arrive **and**
- have not been in or through a [red list country](#) in the 10 days before you arrive in UK

You must be able to provide acceptable proof of your vaccination status to your carrier (ferry, airline or train) when you travel. Acceptable proof is listed [here](#).

If you have been fully vaccinated in the UK, you can scan a document or attach a file showing your NHS COVID Pass to verify your vaccination status. If you do not have a QR code, or you are unable to scan it to verify your vaccination status, select 'No' below and continue. You will be able to verify your vaccination status at the UK border if this applies to you.

You must scan or attach a file with a single QR code, and it must be the QR code proving that you have had a full course of COVID-19 vaccinations. If you scan or upload a file with the incorrect QR code, or that has multiple QR codes, you will not be able to verify your vaccination status.

Testing after you arrive in the UK

You must [book a coronavirus \(COVID-19\) test package](#) for when you arrive in the UK.

- If you have only been in green list countries, you must book a day 2 test.
- If you have been in or travelled through an amber list country or island you must book tests for day 2 and day 8, **unless** you meet the [vaccine eligibility criteria](#).

Test to Release

If you are self-isolating in England, you can choose to use the Test to Release scheme. This could reduce how long you need to self-isolate for.

If you are not required to self-isolate, you do not need to use Test to Release.

If you plan to use Test to Release, [book an extra coronavirus \(COVID-19\) test from an approved Test to Release provider](#).

You must still take tests from the coronavirus travel test package you booked for after you arrive in the UK, even if your Test to Release result means you can end self-isolation early.
